#### **COURSE FORMAT**

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams. May be delivered in online or mixed mode format.

#### **COURSE PREREQUISITES**

45 credits of 100-level or higher coursework; OR 6 NABU credits and CMNS 305

#### **CALENDAR DESCRIPTION**

In this course, students will co-create, plan, and implement a real-world team project designed to enhance the CapU experience for all School of Business students. This non-disposable project will allow the students to identify a need in CSB student community and to tailor the project framework to address this need. Students will be expected to draw upon the skills and knowledge acquired throughout their business program which may include proposal development, marketing, budgeting, project management, technology implementation, event planning, sponsorship development and other related business skills. The end result of term work will be the development and implementation of a sustainable initiative for the School of Business

#### **COURSE NOTE**

It is recommended that students take BADM 318/NABU 318 Project Management as a prerequisite/co-requisite to this course.

### **REQUIRED TEXTS AND/OR RESOURCES**

Specific resources, based upon the project selected, will be provided by the instructor. Students will be expected to draw upon Capilano University library resources in support of their project proposal.

Any instance of academic dishonesty or breach of the standards of academic integrity is serious and students will be held accountable for their actions, whether acting alone or in a group. Violations of academic integrity, including dishonesty in assignments, examinations, or other academic performances, are prohibited and will be handled in accordance with the Student Academic Integrity Procedures.

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating**: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud**: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

• Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);

- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.

# **Sexual Violence and Misconduct**
