## **CALENDAR DESCRIPTION**

This course examines the historical development and the political-economic and cultural dynamics of television as one of the key media of the past 100 years. Using frameworks derived from cultural studies and television studies, the course will explore the world that television created and the ways in which this medium continues to shape contemporary culture.

## **Reading summaries 15%**

The purpose of this is to learn how to summarize readings from course material. At various times during the term you'll be asked to complete the reading summary template on moodle. These assignments will assess your knowledge of Cap Core Learning Outcome #1

## Group assignments 5%

Each class a group will present a connection to the course material at the beginning of class. This is not a review of class reading, but a connection to current TV discourse, events, and debates to help contextualize the reading material.

## In-class assignments 10%

To promote a depth of learning there will be small in-class assignments to help you move from theory to practice.

## TV Analysis Paper 25%

The purpose of this essay is to look carefully at a TV show, of your choice, and focus in one particular point of analysis; race, class, gender, etc. Using academic texts to back up your analysis, this paper deconstructs the text while also recognizing its link to historical, socioeconomic and political events. This assignment will assess your knowledge of Cap Core Learning Outcomes #1, 2, 6 & 7

## Midterm 15%

The purpose will be to assess you understanding of class material thus far. The midterm will This assignment will assess your knowledge of Cap Core Learning Outcomes #1 & 2

## Final exam 20%

The final exam will primary focus on you and your position as a TV viewer. Using an autoethnographic approach the final exam asks you to fully examine all the texts, theories, theorist, debates and issues within the course and tie these with an awareness of your TV viewing environment, stance, habits and taste culture. Focusing, as always, on the wider socio/political/economic factors that come into play with our engagement with media. This assignment will assess your knowledge of Cap Core Learning Outcomes #1, 2, 6 & 7

Since much of the class will be workshop-based you'll be marked on your ability to work with others in the class, work in a professional, respective manner, remain off screens when the instructor or peer requires attention and hand in work in a timely and thoughtful manner.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:
