CALENDAR DESCRIPTION

Retail is a dynamic and fast paced industry. Retail strategy will examine what retail stores are and the different channels that exist. Students will gain an understanding of what retail strategy is and how they can apply it to a career in retail operations management. This course will offer insights into how retailers create customer value and an understanding of CRM. Using a simulation, students will create a strategic business plan for a retailer.

- 6. Construct a retail strategic plan through use of a simulation.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:
