Kris Bulcroft called the meeting to order at 4:00 pm.

1. APPROVAL OF AGENDA

Jackie Snodgrass moved and Robert Campbell seconded that: the Agenda be approved.

2. MINUTES

An error was noted under the Information Item, Update on Student Health and Dental Insurance Proposal. The statement "that the insurance plan will only initially cover students attending the North Vancouver campus, with benefits being extended to the Sechelt and Squamish campuses at a later date" should have read:

"that the insurance plan will initially cover students attending the North Vancouver campus but may also cover students at the Sechelt and Squamish campuses."

Jackie Snodgrass moved and Susan Hogan seconded that: the amended Minutes of the January 11, 2011 meeting be approved.

3. CHAIR AND VICE-CHAIR'S REPORTS

Chair's Report

Kris reported that the recent faculty world cafe had been well attended and there had been good broad-based commentary. Once all the comments have been reviewed and dominant themes identified, a report will be prepared discussing the next steps.

Kris attended the Board retreat on January 22nd. One of the issues covered was how post-secondary institutions similar to Capilano were working to fulfil goals within a changing landscape, both in terms of student needs and funding. The retreat was very productive with discussion on the Board's involvement in trying to meet these goals.

The Fine and Applied Arts Alumni event was very successful, and attendance was good.

Capilano received good publicity for its participation in the Shakeout BC earthquake drill. Kris noted that it was a worthwhile exercise to participate in, and improvements will be made next year.

Kris met students at a recent CSU meeting, and the topic of residential housing at Capilano was raised. As well, a survey conducted in Fall 2010 indicated students generally had a positive attitude towards Capilano. Overall satisfaction with the campus improved; however, there were still some challenges as students were concerned with lack of study and social space, availability of printers, among other things.

Vice-Chair's Report

Marion introduced Brandon Hofmarks, a student in the Business program. Brandon is considering running for one of the student positions on Senate and attended the meeting to observe proceedings.

Marion attended the Board retreat and is looking forward to working with members.

The Committee Restructuring Committee met and had further reviewed the mandates of committees. The Committee will report at the March Senate meeting.

Marion announced that, due to scheduling issues, Kevin Cripps, a representative from the Faculty of Fine and Applied Arts had resigned from Senate effective immediately. Karen McCredie would be addressing by-elections further in the agenda.

(a) EC199903 Academic Appeal Policy

The revisions consisted mainly of clarifying and updating clarity of language, as well as a more specific definition of quorum.

7. GRADING PROFILE COMMITTEE

Graham reported that the committee had met and reviewed feedback received to date on Capilano's grading profiles. Feedback indicated that certain profiles were preferred and, the committee therefore developed two proposed profiles. The first profile could be used for theory-based courses and the second profile could be used for skills-based courses. Members discussed the suitability of the two profiles as they apply to different programs, and how a program that has both skills and academic courses would deal with the profiles. Members were requested to bring the two profiles back to their constituencies for discussion and review. Graham requested that any feedback be received by the end of February.
