• The Minor in Women's and Gender Studies has been developed to formalize this in-demand area of study. The creation of a Minor will establish Women's & Gender Studies as a functional area and will offer all CapU baccalaureate students the opportunity to earn a credential in the discipline. Through internal Indigenous Education and other academic consultations, and external employer and academic consultations, the Minor is a welcomed credential based on its emphasis on applying gender studies to social, scholarly, and professional contexts; and its core themes of critical, intersectional and decolonial approaches to the study of gender and other related social structures and contexts (for example, the study of race, disability, or sexuality). These core themes were identified in consultations as important competencies for work or scholarship in sectors such as education, social and health services, government relations, not-for-profit organizations, and diversity & equity consulting.
