Capilano University’s three Applied Behaviour Analysis (Autism) programs offer a variety of courses in autism, behavioural principles, and behaviour analytic practice. The proposed 18-credit Minor in Applied Behaviour Analysis (ABA) would open ABA courses to students completing their bachelor’s degrees in other disciplines and create a learning opportunity for students looking to build a foundational knowledge of ABA. Furthermore, it might inspire students to pursue

a career in a field in which some behaviour analytic knowledge is required or viewed as an asset, and encourage future studies in ABA. Finally, there are no comparable minor programs in British Columbia or Canada; thus, creation of a minor in ABA would address a sectoral gap.

The courses included in the proposal are current offerings, which means that we have the instructional knowledge and capacity to implement this program by Fall 2024.
