Bachelor of Environment and Society (Environmental Studies) Program Profile Bachelor of Environment and Society (Environmental Sciences) Program Profile Presented by: Cheryl Schreader

The original credit count for the Bachelor of Environment and Society (Environmental Science) program was 123.00 credits. However, during a recent audit of the program, it became evident that the degree could be completed in 120.00 credits. The audit revealed that a number of POST-specific requirements would overlap with university-wide baccalaureate degree requirements, specifically ENGL 100. Many students will be able to satisfy both (1) POST-specific requirements and (2) remaining university-wide baccalaureate degree requirements with 120.0 credits. This will be more desirable from a time and budget student perspective.

Accordingly, the Electives section of both programs have been revised to, among other things, consolidate the breadth and elective requirements, i.e., ENGL 100 and ENGL 220/CMNS 250 have been moved from lower level requirements to the Electives section.

5. SCHOOL OF MOTION PICTURE ARTS

FILM 333 – Ultra Low-Budget Feature Production Presented by: Michael Thoma and David Ray

FILM 333 – Ultra Low-Budget Feature Production is a new 3.0-credit course that would expand course offerings from the Bosa Centre for Film and Animation during the summer semester. New digital technology allows for high-quality video to be shot on a cell phone, including feature length films which can be produced with small crews, minimum technical demands, a short schedule, and an ultra-low budget. The course will present the opportunity to produce a feature length film from start to finish.

On review and discussion, and from a quality assurance perspective, the Committee members raised several concerns regarding the course outline presented, particularly with respect to the pre-requisites and course note requiring an interview and instructor approval to register, as well as the learning outcomes. In this regard, it was suggested that further work be completed on the course outline. It was therefore agreed that the motion be postponed indefinitely, and the presenters were invited to return to a future meeting.

- Musical Theatre Diploma Continuation Requirement
- Acting for Stage and Screen Diploma Continuation Requirement
 - The department recently determined that the previous continuation requirements were outdated. In this regard, the continuation requirements were reviewed and updated to reflect current practice, including changing the required GPA from a 2.67 (a B- average) to a 3.00 (a B average), among other things. In addition, the presenter indicated that, based on consultation with Curriculum and the Musical Theatre faculty, the requirement for an audition for both programs is being removed to avoid various complications and a perceived lack of transparency.

 - The Acting for Stage and Screen Certificate program profile's program note was revised to state: "This program does not accept applications. However, Acting for Stage & Screen Diploma students can contact the department for more information about earning this credential."
