COURSE FORMAT

A minimum scheduled eight hours per student of classes, workshops, mentored production meetings, studio instruction and supervised editing lab work over a fifteen-week period. Students are advised that an increased schedule of production hours outside of class time (beyond the above-listed minimum) is recommended to help ensure a high degree of quality in the completed projects.

COURSE PREREQUISITES

8.5 credits of 400 level MOPA.

CALENDAR DESCRIPTION

This course explores the art and practice of filmed dramatic entertainment. It is designed to provide mentored hands-on experience in the artistic disciplines as well as the industrial practices of film and video production. Each student produces a short, episode, proof of concept, teaser, script, business plan or further written and/or visual materials in support of their Development Project. Although there is faculty supervision on all four-hundred level projects, students are expected to develop and produce work independently. Depending on the nature of the project, students may work alone or in creative teams.

COURSE CONTENT

Each student produces one of several development options from:

- Short film – 10 to 15 minutes
- Webisode – 8 to 10 minutes
- Proof of concept – teaser for a feature
- Script – short film, spec TV script, feature, documentary proposal
- Business plan for an entertainment related business
- Further written and/or visual materials in support of their Development Project.

PROFESSIONAL BEHAVIOUR OUTCOMES and MEASUREMENT CRITERIA

- Can clearly defend outcomes in a professional and ethical manner

7. Communication

Measurement criteria:

- Displays appropriate oral communication skills within the group
- Written communication skills are appropriate for the position with timely completion of paperwork

PARTICIPATION

The grade for class participation is based on both the frequency and the quality of students' comments, questions and observations, with the emphasis on quality. The quality is determined by, among other things, the relevance, insight and clarity of remarks. Students are expected to demonstrate a professional attitude and behaviour towards their work, fellow-students, and their instructor. Students should demonstrate reliability, respect for and co-operation with colleagues. A willingness to work calmly and courteously under difficult conditions as well as a determination to achieve first-class work while meeting deadlines is necessary in this course. Students should have respect for equipment and systems, and a constructive response to criticism.

Arriving more than 20 minutes after the commencement of class, or leaving early, will be considered an absence. Students with three unexcused absences will fail the course. When the students are absent from the course, they are still responsible for the material covered during their absence, including announcements, assigned readings and handouts.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;

DEPARTMENT OPERATIONAL DETAILS

MOTION PICTURE ARTS STANDARDS FOR PROFESSIONAL BEHAVIOUR

Professional behaviour is essential in employment situations in the film and television industry. Professional behaviour, combined with professional technical and craft skills are the essential components that directors, producers, writers, actors, cinematographers, editors, agents, funders, broadcasters and distributors consider when deciding to build a team, hire, cast or green light a project. By acknowledging this, the Motion Picture Arts program fosters professional behaviour by evaluating each student according to these standards. In all student projects, professional behaviour forms part of the mark, students will be given interim reports in order to adjust behaviour that needs improvement. These standards reflect the values of professionalism in the film and television industry and represent the expected standard of behaviour required of employment in the field. The desired behaviours are described below as “outcomes” which are followed by a list of criteria against which the student’s behaviour will be measured.

STUDIO FILMING DISCIPLINE

Students must be dressed appropriately. Wet and cold weather requires waterproof and warm clothing. Students are required to wear work clothes for technical and production sessions. Clothing may be subjected to dirt, paint and dust. Sturdy shoes are a must. No food or beverages are allowed on set during production activities and during technical classes. Disruptive students will be asked to leave.
