Private music instruction designed to meet the individual needs of each student and develop the skills necessary to prepare an audition for 100-level PMI courses.

- Improve playing proficiency on their concentration instrument in these areas:
  - o Repertoire
  - o Technique
  - o Sight reading
  - o Musicianship

#### **COURSE CONTENT**

This course comprises 14 weekly lessons of 50 minutes duration in the student's concentration area. PMIP students are expected to study exclusively with faculty at Capilano University.

The PMI instructor will assess the level of musical and technical development of each student during the first 2-4 lessons. For the remaining lessons, the instructor will devise a series of lesson plans unique to each student which will enable the student to cover the following material:

- Technique:
  - Major Keys
  - Minor Keys
- Scales: Major, minor (harmonic and melodic forms), chromatic scales
- Chords: Common chords
- Arpeggios: Common chords
- Sight reading
- Repertoire: Students must prepare two works of contrasting style. Selections of repertoire must meet the instructor’s approval regarding length, difficulty, and style. Audition pieces are not to be repeated in the juries. Students may not repeat a work that has been evaluated in a previous jury.

The instructor will evaluate student performance both in lessons and the jury according to the above Learning Outcomes, taking into consideration the level of responsibility, capability, and achievement expected from a second-year student.

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating:** Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;

### **Sexual Violence and Misconduct**
