#### **COURSE FORMAT**

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

#### **CALENDAR DESCRIPTION**

This course introduces concepts, theories, and issues in the psychology of gender, gender roles, and gender relations. Gender research in psychology is examined in relation to social and cultural contexts, with a specific focus on bodies, mental health, gender and psychiatric diagnoses, socialization, relationships, personality, and identity. The course explores intersectional, Indigenous and anticolonial perspectives on gender, and students will examine how ideas about gender are shaped by specific social, cultural, and historical contexts.

#### **COURSE NOTE**

WGST 210 is equivalent to WMST 110. Duplicate credit will not be granted for this course and WMST 110. Completion of WGST 100 and/or WGST 111 is recommended.

#### **COURSE STUDENT LEARNING OUTCOMES**

**On successful completion of this course, students will be able to do the following:**

- Understand key concepts in the field of psychology related to gender and how these views shape and constrain how gender research in psychology is performed.
- Engage in constructive discourse on the psychology behind gender.

- Analyze changes in sex and gender research done in psychology.
- Reflect on relevant social and cultural changes to discourses “outside” of psychology.
- Examine how gender, power, and culture interrelate in shaping how we think about and engage with bodies, identities, and mental health.

**COURSE CONTENT**

Weeks 1 – 3: Introduction to core disciplinary concepts and theories, the biology of sex and gender, the history and methods of gender research in psychology

Week 4-6: Psychological understandings of gender and gender roles and gender role attitudes

Weeks 7-9: Gender and achievement, communication, and friendship

Weeks 10-12: Gender, relationships, and mental health

Week 13: Indigenous perspectives on gender

Weeks 14-15: Final exam period

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating:** Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.

### **Sexual Violence and Misconduct**
