COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION

This course examines the role of gender in politics and public policy through critical, intersectional, feminist, anticolonial, and socio-political frameworks. Learners will examine the role that political institutions and public policies play in creating, challenging, and overcoming gender-based inequality. While Canadian political and policy-based discourses are the core focus, this course also engages with gender, politics, and public policy on a global scale.

COURSE NOTE

WGST 213 is equivalent to WMST 113. Duplicate credit will not be granted for this course and WMST 113. Completion of WGST 100 and/or WGST 111 is recommended.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Understand the role that gender plays in politics and policy-making in Canada and internationally.
- Develop critical thinking and analytical skills to consider the gendered elements of politics and policies through intersectional, feminist, Indigenous, and anticolonial lenses.

- Engage in critical, contextual, and comparative analyse to appreciate the implications of gender inequality in political discourse and public policy.
- Discuss resources, strategies, and potential solutions for addressing gender inequity in politics and policy, including activism, policy development, and social change.

COURSE CONTENT

- Weeks 1 3: Conceptual and theoretical understanding of gender, politics, and public policy, including critical, intersectional, feminist, anticolonial, and socio-political frameworks
- Weeks 4-6: Gender, politics, and political participation
- Weeks 7-9: Policy issues, including fundamental rights, personhood, work, bodies, and reproduction
- Weeks 10-11: Activism and change on local, national, and global scales
- Weeks 12-13: Synthesis and application of core ideas
- Weeks 14-15: Final exam period

Cheating: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;

- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
