COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION

This course uses an intersectional feminist perspective to examine how societal notions of gender shape our built environments and colour our perceptions of the world around us. Gender differences are apparent in how we live, work, travel, and explore. Drawing on geographical topics ranging from our everyday home and work experiences to the trafficking of people across borders, this course explores gender roles and patterns from around the world and their spatial implications in cultures.

COURSE NOTE

WGST 215 is equivalent to WMST 115. Duplicate credit will not be granted for this course and WMST 115. Completion of WGST 100 and/or WGST 111 is recommended.

- Explain the research methodology of intersectional feminist geographic study

- Analyse spatial patterns within the human landscape from an intersectional feminist and geographic perspective
- Utilize maps as a method of conveying gender patterns and geographic issues

COURSE CONTENT

Weeks 1 – 3: Introduction to core disciplinary concepts including defining human geography, social construction of space and identity and relationships to place
 Weeks 5-6: Gender and urban city spaces: race, ethnicity, class, and consumerism
 Weeks 7-9: Migrations: gendered labour, human trafficking, and the environment
 Weeks 10-12: (De)colonial institutions and empire
 Weeks 12-13: Synthesis and application of core ideas
 Weeks 14-15: Final Exam Period

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.
