# COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

# **CALENDAR DESCRIPTION**

This course applies an intersectional feminist analysis to the study of gender in popular culture. Drawing on a variety of media which may include advertising, digital media (including film and series), comic books, video games, popular fiction, podcasts and magazines, students will examine the representation of diverse genders. The course will also explore how popular culture often functions to reinforce social norms concerning gender roles and identities, while also acting as sites of resistance through challenging gender norms.

## COURSE NOTE

WGST 250 is equivalent to WMST 150. Duplicate credit will not be granted for this course and WMST 150. Completion of one of the following courses is recommended: WGST 100, WGST 111, SOC 100, CMNS 112, or CMNS 132.

# On successful completion of this course, students will be able to do the following:

- Describe how gender is socially constructed in popular cultural images and discourses
- Explain how representations of gender in popular culture have developed historically

- Analyse the relationships between gender and other identity categories (e.g., class, race, ethnicity, sexuality) from a critical feminist perspective
- Identify the connotative messages underlying forms of popular media using critical readings of media
- Assess the effectiveness of resistant or alternative forms of popular culture in countering dominant gender ideologies and stereotypes

## **COURSE CONTENT**

- Weeks 1 5: Introduction to core concepts: defining popular culture, popular culture analysis in relation to intersectional feminism, colonization, and Indigenous media cultures
- Weeks 6-8: Histories of popular cultural production of the past century
- Weeks 9-11: Representations of gendered bodies: women and femininities, men and masculinities and queer/trans/non-binary representations
- Weeks 12-13: Synthesis and application of core ideas to topics in contemporary popular culture

Weeks 14-15: Final Exam Period

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

- Copying or attempting to copy the work of another during an assessment;

Fraud: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
