COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

COURSE PREREQUISITES

45 credits of 100-level or higher coursework

CALENDAR DESCRIPTION

This course examines social, cultural, and political constructions of masculinity in the past and present. The course considers the interplay between the dominant expression of a “hegemonic masculinity” and the co-existence and persistence of “multiple masculinities” that often elude it or resist it. Course readings will engage with emerging forms of (cis, trans*, new) masculinities, situating them against the background of new developments in popular and academic feminist critique.

COURSE NOTE

Completion of WGST 100 and/or a 200-level WGST course is recommended.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Synthesize concepts from masculinity studies in order to think critically about the construction of masculinity across various intersectional contexts;

- Demonstrate the roles various social institutions play in shaping understandings of hegemonic masculinity;
- Analyze literary, artistic, social, and cultural artifacts that are informed by or demonstrate the tensions, anxieties, and aspirations embedded in manhood and masculinity;
- Identify diversities among masculinities and femininities;
- Apply an intersectional approach to masculinity-studies-related issues and current areas of controversy and debate;
- Apply scholarly research skills in topics in masculinity studies.

COURSE CONTENT

Weeks 1 – 4: Theorizing masculinities: the social construction of genders and sexualities
 Weeks 5-7: Critiquing toxic masculinities and exploring alternative expressions of masculinity
 Weeks 8-12: Case studies of masculinities in media, performance, entertainment and sport
 Weeks 13: Term synthesis
 Weeks 14-15: Final Exam Period

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
